Rules and Regulations for Burial

- 1. The Daarul Barzakh Maqbarah is the sole property of Al Maad Al Islami Inc. Following rules and regulations must be agreed upon and strictly observed at all times by all visitors.
- 2. No plots will be deeded to anyone before or after burial. The entire cemetery property will continue to remain under the ownership of Al Maad Al Islami Inc.
- 3. Upon application on prescribed form and payment of dues, Al Maad Al Islami Inc will allocate cemetery lot number and authorize the burial. Al Maad Al Islami reserves the right to deny authorization for burial to any individual without giving any reasons. Reservations for any specific lot location or for a group of lots for family members are not allowed.
- 4. All burial shall take place under the supervision of an authorized Al Maad Al Islami representative. Washed and prepared body from the funeral home must be received at the cemetery at the designated time which will be no later than an hour before the sunset.
- 5. No caskets shall be used for burial. The body will be buried in shroud and a pressure treated plywood or alternative wooden material will be used to create a small cavity for the body before backfilling the grave.
- **6.** Top of all graves shall initially be raised no more than 1" and will be grassed once the soil settles and the top becomes flat.
- 7. Graves will be marked with a standard stone marker, flushed with the ground, engraved with the name and date of birth and death of deceased. Al Maad Al Islami Inc will provide and install this marker.
- 8. Unauthorized markers, monuments, permanent or temporary decorations of any kind, flowers, plants and shrubs are not permitted. Any violation will result in removal of such construction, without exception or notice to the family and the applicant agrees to pay for the cost of this removal.
- 9. Picture taking and/or videotaping of any kind during burial is strictly prohibited. Al Maad Al Islami reserves the right to refuse any ritual before, during or after the burial if it has no grounds in Islamic jurisprudence.
- 10. Children of under the age of 15 years must be accompanied by adults. No pets are allowed in the Cemetery. Parking is allowed only in designated areas.
- 11. Cemetery will remain gated and locked except during published times when it will be open for family/visitors. Out of town visitors may contact Al Maad Al Islami Inc for permission to visit at other times.
- **12.** Al Maad Al Islami Inc shall not be responsible for any damage or loss to property or person while on the Cemetery premises and reserves the right to refuse entry to any person.

I have read, agreed and promise to comply with the above Rules and Regulations for burial at all times. I further promise to comply with any future rules and regulations, which may be set forth by Al Maad Al Islami Inc or any government agency.
